ORDER:

In the reference (2) read above, Acharya Nagarjuna University, Guntur has granted permanent affiliation to "Velagapudi Rama Krishna Siddhartha Engineering College, Vijayawada", during the period of Affiliation of the College to Acharya Nagarjuna University, Guntur based on the UGC letter under reference (1) read above. Subsequently, the Affiliation of the College has been changed to JNTU Kakinada vide reference (3) read above.

One man Committee has been constituted and the committee in its report has recommended for grant of autonomy to Velagapudi Rama Krishna Siddhartha Engineering College, Vijayawada, affiliated to JNTU Kakinada, vide reference (4) read above.

Under the circumstances as stated above and in pursuance of the contents laid down in the UGC letter (1) read above, the Vice-Chancellor, JNTU Kakinada, is pleased to confer autonomous status on the Velagapudi Rama Krishna Siddhartha Engineering College, Vijayawada, up to the Academic year 2011-12, subject to fulfillment of the following conditions.

- a. Velagapudi Rama Krishna Siddhartha Engineering College, Vijayawada shall continue its affiliation to JNTUK in future also at least till the recommended period of autonomy expires. The autonomy shall cease to exist on discontinuation of affiliation.
- b. The students presently enrolled in the Velagapudi Rama Krishna Siddhartha Engineering College, Vijayawada, shall continue to be governed by the academic regulations of JNTU Kakinada.
- c. The admission procedures to be followed by the Velagapudi Rama Krishna Siddhartha Engineering College, Vijayawada shall continue to remain the same as those of APSCHE/JNTUK for various programs run by it even after acquiring autonomous status.
- d. The autonomous status for the Velagapudi Rama Krishna Siddhartha Engineering College, shall come into force with effect from the academic year 2010-11.
- e. The college shall follow the guidelines issued by the UGC in all matters.
- f. The college shall constitute the necessary Statutory Bodies and inform the University.
- g. There shall be no financial commitment on the part of JNTUK and the college shall continue to pay all administrative/affiliation fees due to the University as usual.
- h. These orders are issued subject to ratification by the Monitoring & Development Committee of JNTUK.
