**Subject: Tuition Fee Payment Reminder for the Academic Year (2024-2025)**

Dear Students

This is to bring to your attention that the 5<sup>th</sup> Semester & 7<sup>th</sup> Semester End Examinations are scheduled to commence on 25<sup>th</sup> November 2024.

It has come to our notice that certain students who are recipients of the JVD Government Scholarship for the 2<sup>nd</sup> Year & 3<sup>rd</sup> Year I Phase have had their scholarship amounts deposited by the Government into their mothers' accounts. However, despite multiple reminders, some of these students have not yet completed the payment of their tuition fees. A similar situation has been observed with SC students availing scholarships from both the Central and State Governments.

In this regard, we kindly remind all students covered under the JVD Government Scholarship Scheme, as well as other applicable government scholarship schemes, that as per the rules and regulations of the institution, **hall tickets for the upcoming semester end examinations will not be issued to students who have not cleared their fee dues.** Failure to settle the pending fees will also result in students being ineligible to appear for the 7<sup>th</sup> Semester examinations.

To avoid any inconvenience, we strongly instruct you to ensure the payment of the outstanding tuition fee at the earliest. Kindly treat this as a final reminder and take immediate steps to fulfil the requirement.
