

- Regular Staff in Workshops & Labs must be appointed as per AICTE norms

LAND AND BUILDING


- Exclusive land & Building must be provided for the proposed programme as per norms.
- Basic amenities like toilets, parking, hostel, common room, canteen etc. must be provided as per norms.
- Separate Hostel facilities should be provided to Boys & Girls.

LIBRARY, LABS AND WORKSHOPS


- Adequate Library space must be provided and it should be augmented as per AICTE norms.
