ii) Suggestions:

Sri. P.V. Rao, Director, Pennar Industries & Pennar Global, Hyderabad, suggested to offer courses on Economics, Finance, Taxation, Banking, Direct & Indirect taxes etc., in the B.Tech Program in any one of the year and also conduct special lectures for entrepreneurship development to encourage students to become entrepreneurs. Recently it is observed that many college students are lacking fluency in English language and they are not able to speak 10 to 15 minutes on any important topic even though they have a very high percentage of marks in the course. Today communication skills are more important for getting good job opportunities for Engineering students or to become entrepreneurs.

Sri. M. Rajayya, Vice – President, Siddhartha Academy and Convener of the College expressed his thanks to Sri. P.V. Rao for his noble advice and advised the Principal to organize special classes for development of communication skills of students and advised to put more focus on this issue.

Dr. A.V. Ratna Prasad, Principal informed that Economics and Accountancy subjects have already been offered in our B.Tech course and we have been conducting special classes on Communication skills and English from second year onwards and continue to keep sincere efforts further.

Sri. Abburi Vidya Sagar Chairman/Managing Director, Avantel Ltd, Industrialist, informed that Hyderabad Management association is providing online entrepreneur development and communication skills related courses with eminent industry experts. Industry like Tata, L & T etc., experts are giving lectures from this platform. Students can take as an elective course with in a duration of 20 to 30 hours in a structured way i.e. theory cum practical examples. Mr. Ramchandra, M.D will give helping hand towards this program.

Sri.D.Rama Krishna, MD, Efftronics Pvt. Ltd., Special invitee suggested that institute need to put major efforts towards algorithms building. Faculty and students together need to give importance to build algorithms in all departments including Mechancial and Civil. Most of the MNCs paying high salaries to the students who knows about algorithms building. At present teachers are teaching only algorithms, major directions is needed towards building algorithms.

He also felt that the future of the Private Engineering colleges in the state is affecting due to low fee structure and students' admission input in some of the core branches. At present Industries are paying high salaries across the world, so we need to retain the capable faculty by providing good salaries.
