2. National Board of Accreditation has decided that in all cases where UG Engineering programs of an Institution were granted accreditation for a period of 5 years in Tier-I/II format and if they do not meet all the parameters of prequalifiers for extension of duration of accreditation from 5 years to 6 years, the period of accreditation of these program(s) shall be extended by one year subject to the condition that they meet all the parameters of the Pre-visit qualifiers for accreditation of 3 years. The Pre-visit qualifiers submitted by Velagapudi Ramakrishna Siddhartha Engineering College, Vijayawada Machilipatnam, Chalasani Nagar, Kanuru, Vijayawada, Andhra Pradesh- 520007 in respect of the UG- Electrical & Electronics Engineering program has been considered. The program is meeting all the parameters of pre-visit qualifiers for accreditation of 3 years.
