In respect of the programmes which have been granted provisional accreditation for 2 years, Velagpudi Ramakrishna Siddhartha Engineering College (Autonomous), Kunuru Post, Vijayawada-520007, Andhra Pradesh should submit the Self Assessment Report alongwith a Compliance Report atleast after one year to be considered by the Engineering Evaluation and Accreditation Committee (EEAC) to formulate a view whether compliance report is enough to recommend for accreditation or a visit to the Institute is necessary. The recommendations of the EEAC will be considered by the Sub-Committee of the Academic Advisory Committee and the Executive Committee for decision.

4. The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to Velagpudi Ramakrishna Siddhartha Engineering College (Autonomous), Kunuru Post, Vijayawada-520007, Andhra Pradesh as a whole. As such the Institute should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. 
