  - Appointment of Nodal officer for Monitoring and Evaluation for TEQIP Phase – II
  - Release of Rs. 20,00,000/- by Siddhartha Academy of General and Technical Education to the college as an advance to meet the expenditure under TEQIP activities. The advance amount will be reimbursed as and when the 1<sup>st</sup> phase of grant is released.
  - Submission of report on equity action plan from October 2011 to March 2012 to SPFU, Hyderabad.
  - > Submission of FMR from 01-04-2012 to 30-06-2012 to SPFU, Hyderabad.

He also informed that the college is organizing FDPs, workshops and other activities given in PIP with the college funds until the college receive the grant, and upon on receiving the grant the amount will be reimbursed from TEQIP fund as per the guidelines of SPFU and NPIU.
