#### Item-2. To present information regarding AICTE – CII National Award for Best Industry linked Institute for Civil Engineering-2019.

Dr.A.V.Ratna Prasad, Principal informed that the Department of Civil Engineering received AICTE – CII National Award - 2019 for Best Industry linked Institute. Further he said that the VRSEC rated "**PLATINUM**" by AICTE – CII survey, for I.I.I successively third time in 2019. Out of 714 institutes participated in full survey, 39 are shortlisted and among them 9 are awarded in 9 disciplines (one in each discipline) as best institutes. In Civil Engineering Our College stood first. During the past two years the department completed 4000 jobs to Govt. & Non-Govt. organizations under consultancy & testing activity generating a revenue of 250 Lakhs / annum in addition to Research Services of Rs.25-30 lakhs. Four Industry offered courses introduced in curriculum, three in PG and one in UG and these courses are delivered by Adjunct faculty from Industry. The Department of Civil Engineering is well known nationally for its excellent Industry Institute Iteration.

### **Continuous Evaluation (CE)**

Compensatory Test :

A COMPENSATORY TEST will be provided for those students remained absent for the TEST due to a valid/ unavoidable circumstances, like:

- a. Student seeking prior leave on account of:
  - i. Accident or severe illness leading to hospitalization, which disables the student from writing the TEST.
  - ii. A calamity in the family (first relation Only- Parents, Grandparents and Siblings) barring the student from writing the TEST.
- iii. In the event of (i) and (ii) above, it is mandatory on the part of student / parent to inform the respective departmental authorities (Proctor/HOD) immediately through email or mobile message and submit a prior leave request. If the information reaches the Proctor first, it is the responsibility of the Proctor to immediately intimate the HOD and record the same in the Proctor's diary without fail.
- iv. After such an event at the time of reporting to the College, the student must submit all the relevant reports/certificates from the competent authority for approval of the prior leave request. The prior leave request will then be converted to official leave and an endorsement will be issued by the committee appointed for the purpose, based on which the student becomes eligible for the COMPENSATORY TEST
- v. Students, who have sought prior permission from concerned HOD through proper channel, and there after permitted by the college for taking part in important curricular/ co-curricular/ extra-curricular activities like NCC/NSS/Sports/ Cultural/ Project Competitions/ Hackathons/ Technical events at University/ State/ National/ International levels/ Off – Campus Placements.
- vi. After such an event, at the time of reporting to the College, the student must submit the proof of participation/ certificate from the competent authority for approval of the prior leave request. The prior leave request will then be converted to official leave and an endorsement will be issued by the Committee, based on which the student becomes eligible for the COMPENSATORY TEST.
- vii. Any intimation after the completion of regular TESTs and/or Non-submission of report/certificate will be considered as absent for the TEST and the student will be awarded ZERO marks in the respective TESTs. No further requests will be entertained in this regard.
- viii. The committee headed by Principal and two professors as members will scrutinize the request of the student, if genuine, the prior leave request will be converted into official leave.

ix. The COMPENSATORY TEST is not to be treated as an improvement TEST, rather it is to be treated as an opportunity provided to student to make good of academic loss due to the reasons as cited above.

Dr.R.Srinivasa Rao, Director, Academic Planning, JNTUK and Dr.V.V.Subba Rao, Principal JNTU College of Engineering, Ananthapur, University Nominees expressed that only permission may be given to conduct only for Assignment Test not sessional examination.

After discussions, the Academic Council approved the following resolution w.r.t. conduct of Compensatory Assignment Test w.e.f. even semester of 2019-2020 Academic Year.

#### COMPENSATORY ASSIGNMENT TEST:

A COMPENSATORY ASSIGNMENT TEST will be provided for those students remained absent for the TEST due to a valid/ unavoidable circumstances, like:

- a. Student seeking prior leave on account of:
  - i) Accident or severe illness leading to hospitalization, which disables the student from writing the Assignment Test.
  - ii) A calamity in the family (first relation Only- Parents, Grandparents and Siblings) barring the student from writing the Assignment Test.

#### Mandatory Requirement :

- In the event of (i) and (ii) above, it is mandatory on the part of student / parent to inform the respective departmental authorities (Proctor/HOD) immediately through email or mobile message and submit a prior leave request. If the information reaches the Proctor first, it is the responsibility of the Proctor to immediately intimate the HOD and record the same in the Proctor's diary without fail.
- After such an event at the time of reporting to the College, the student must submit all the relevant reports/certificates from the competent authority for approval of the prior leave request. The prior leave request will then be converted to official leave and an endorsement will be issued by the committee appointed for the purpose, based on which the student becomes eligible for the Compensatory Assignment Test.
- b. Students, who have sought prior permission from concerned HOD through proper channel, and there after permitted by the college for taking part in important curricular/ co-curricular/ extra-curricular activities like NCC/NSS/Sports/ Cultural/ Project Competitions/ Hackathons/ Technical events at University/ State/ National/ International levels/ Off – Campus Placements.
  - After such an event, at the time of reporting to the College, the student must submit the proof of participation/ certificate from the competent authority for approval of the prior leave request. The prior leave request will then be converted to official leave and an endorsement will be issued by the Committee, based on which the student becomes eligible for the Compensatory Assignment Test.
  - Any intimation after the completion of regular Assignment Tests and/or Non submission of report/certificate will be considered as absent for the Assignment Test and the student will be awarded ZERO marks in the respective Assignment Tests. No further requests will be entertained in this regard.

- The committee headed by Principal and two Professors as members will scrutinize the request of the student, if genuine, the prior leave request will be converted into official leave.
- The Compensatory Assignment Test is not to be treated as an improvement Assignment Test, rather it is to be treated as an opportunity provided to student to make good of academic loss due to the reasons as cited above.

# 9. To consider and approve the grant of attendance on medical grounds / participation in important Curricular/ Co- Curricular/ Extra – Curricular activities/ Off Campus Placements.

Dr.A.V.Ratna Prasad, Principal presented the following information w.r.t. the **g**rant of attendance on medical grounds / participation in important Curricular/ Co- Curricular/ Extra – Curricular activities/ Off Campus Placements.

#### **Grant of Attendance Benefit:**

The Students shall put in a minimum attendance of 75% from all the courses put together offered during a semester to become eligible for appearing in semester end examinations.

However, the cases of students who participate in various important Curricular/ Co- Curricular/ Extra – Curricular activities organized at University/ State/ National/ International levels/ Off Campus Placements representing the college shall be considered and given due consideration for attendance benefit.

The benefit of attendance may be allowed only on the basis of production of a certificate from organizer of the event.

However, the total period of absence in case of state/national level sports events is 30 days and the period of absence in international sports events is 45 days including the Journey period in an academic year as the UGC letter dated 18-08-1994.

The committee headed by Principal and two professors as a members will scrutinize the request of the student for grant of attendance, if genuine, the request will be considered.

After thorough discussions, the Academic Council approved the above regulations presented by the Principal w.r.t. the grant of attendance on medical grounds / participation in important Curricular/ Co- Curricular/ Extra – Curricular activities/ Off Campus Placements w.e.f. even semester of 2019-2020 Academic Year.

#### 10. To Consider and approve amended regulation w.r.t. Self learning courses.

Dr.A.V.Ratna Prasad, Principal presented the following amended regulations w.r.t. self learning courses.

- 1. For the Open Elective III offered during V Semester B Tech course, the students may be permitted to register and complete the course during III, IV and V semesters and produce the certificate before the last instruction day of the Fifth Semester
- For the Open Elective V offered during VIII Semester B Tech course, the students may be permitted to register and complete the course during VI, VII and VIII semesters and produce the certificate before the last instruction day of the Eighth Semester
- 3. The courses which don't form part of the curriculum and skill oriented courses should be recommended provided the prerequisites are attained by the students.

- 4. The courses shall be approved in the respective boards of studies in advance.
- 5. The student is said to be qualified in the course if and only if the MOOCs course providers shall issue a certificate with the marks secured.

After discussions, the Academic Council approved amended regulations w.r.t.self learning courses presented by the Principal of the College w.e.f. even semester of 2019-2020 Academic Year.

#### **11.** Any other point with the permission of the Chairman.

a) Dr.A.V.Ratna Prasad, Principal presented the following proposal for Exemption in attending the class work and conduct of special examinations: Securing placements in Final Sem / Year.

Some of the students of final year B.Tech, M.Tech, MCA and MBA got appointment in Grama Sachivalayam, Government of A.P. Exemption may be granted in attendance and writing special continuous assessment examinations be permitted to conduct as per the existing academic regulation.

After discussions, the Academic Council denied same, but the members of the council suggested "Break in Study" permission is to be obtained from the Affiliating University for the students who got selected in Grama Sachivalayam, Govt. of A.P. during this Academic Year 2019-2020 and wish to continue their final semester in the later stage with in the maximum duration allowed as per the Academic regulations.
