- College has introduced B.Tech Minor and B.Tech (Hons) programmes, following the guidelines of AICTE and APSCHE w.e.f from A.Y 2020-21.

Dr.A.V.Ratna Prasad, explained that he has already shown percentages for some of the parameters in strategic plan, however same will be incorporated to other parameters.

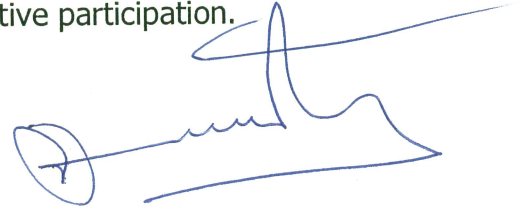
