Dr. GVR Prasada Raju, suggested to encourage the faculty for doing Ph.Ds and increase the faculty strength with a minimum of 50% since, the V.R.Siddharhta Engineering College is the oldest and one of the premier institutions in A.P.

Dr. A.V. Ratna Prasad, Principal informed that we have already taken initiative to increase the Ph.D faculty to 50% by the end of 2020.  To review the status of PG admissions and proposed to introduce new PG programme i.e. "Data Sciences" and discontinuation of CST in IT department.

In view of very less number of admissions in CST it is proposed to discontinue **Computer Science and Technology** offered by **IT department** and introduce new specialization **'Data Sciences''**.

After discussions it is resolved to approve the discontinuance of **CST** offered by IT department and introduce **Data Sciences** from the A.Y. 2019-20.

Dr.A.V.Ratna Prasad, Principal informed that the PG Programme CAD/CAM offered by Department of Mechanical Engineering is not having demand in PGECET counselling, since many colleges are offering CAD/CAM in this region and students are opting their near by colleges. It is felt that either Product Design and Manufacturing (or) Engineering Design may be chosen in place of CAD/CAM to attract more students as these specializations are not available in many of the colleges in our region & also A.P.

Sri Rajendra Velagapudi, M.D & CEO, Cyient DLM suggested to modify **Product Design** and **Manufacturing** as a **Product Design and Digital Manufacturing** and Dr.G.V.R.Prasad Raju garu suggested to look into AICTE nomenclature before finalizing.
