Dr. Velagapudi Rajendra, Managing Director & CEO., Cyient DLM, Head - Business Excellence, Hyderabad, Industrialist, suggested that instead of doing projects in bits and pieces for agricultural development, students may be guided to undertake projects with comprehensive vision for end to end solution utilizing AI techniques & Machine Learning.

Further, he informed that AICTE/MoE is also soon launching 12 Higher Modules (for Associate and Professors). He is coordinating a Higher Module on "Institutional Management for Entrepreneurship". His Module is complete but all will be launched together in September 2021.

Sri. V.S. Chalapathi Rao, Principal, Govt. Polytechnic, Vijayawada, State Govt. Nominee, congratulated the college management & faculty for the steps taken towards R & D, Placements training etc., for the benefit of the students.
