ADMISSIONS INTO FIRST B.TECH. FOR THE ACADEMIC YEAR 2021-2022

INFORMATION TO APPLICANTS AND PARENTS

Category 'A' & Category 'B' admissions

The Government of Andhra Pradesh, in G.O.Ms.No.48 dt.04.09.2021, prescribed the following procedure for filling-up ofseats in I B.Tech. for the year 2021-2022, gist of which is given below:

- i) 70% of the total seats in the I year will be allotted by the Convenor(Admissions) EAPCET. These will be allotted basing on rank in EAPCET following the rules of reservation as prescribed by the State Government.
- ii) 15% of the seats will be filled by respective Engineering Colleges under Category B-NRI / NRI Sponsored Candidates. NRI means a candidate born to a parent of Indian origin residing outside the country and passed qualifying examination or equivalent. NRI Sponsored Candidate means those who have their permanent residence in India, passed the qualifying examination and sponsored by a relative with NRI status.
- iii) Minimum eligible marks in the qualifying exam is 50% or CGPA 5 on a scale of 10 to apply for admissions under NRI /NRI Sponsored category. The allotment of seats will be in the order of merit.
- iv) Tuition fee prescribed by State Government for this category is US\$ 5,000 (US Dollars Five thousand) per annum.
- v) Applications under this category are being issued in the College and can be downloaded from the College website as well.
- vi) The last date for submission of filled-in application forms is 15.09.2021
- vii) The selected list of candidates under this category will be displayed in the College on 16.09.2021.
- viii)Those selected should immediately submit all originals the list of which is given in the application form and should be able to remit US\$ 5,000 towards I year fees.

- ix) Any unfilled seats under this category will be converted into category B Non NRI seats and they will be filled-up by Convenor (Admissions) EAPCET through online along with filling-up of 70% seats under merit category.
- x) The Convenor(Admissions), EAPCET will issue a notification to fill-up category
 B Non NRI seats along with category A Convenor Quota seats through online
 web based counselling.
- xi) The fees for Category A Convenor Quota is Rs.66,200/- per annum. The fees for Category B – Non NRI seats will be higher and will be notified by the College to the Convenor(Admissions), EAPCET branch wise and the same will be known to the candidates through Convenor(Admissions) EAPCET.
- xii) Candidates admitted under Category B Non NRI seats are not eligible for any Governmental assistance or schemes.
- xiii)Candidates should apply separately for Category A and Category B Non NRI seats after notification to be issued by Convenor(Admissions), EAPCET.
- xiv) Candidates who secure seats in Category B- Non NRI Quota can apply for Category A seats under Convenor Quota in subsequent rounds of counselling provided they are qualified in EAPCET.
