- Addition in M.Tech Academic Regulations under eligibility requirement for appearing at M. Tech project examinations.
 - ✓ ***A candidate shall be permitted to submit his / her dissertation / Thesis only after acquiring credits of all theory, practical and project related courses including mandatory and audit courses.***

- Addition in M.Tech (M.Tech -19) Academic Regulations under 7.7 Internship / Industry offered course will be as follows.

The candidate shall submit the comprehensive report to the department. The report will be evaluated for 100 marks by the Review Committee consisting of Head of the department, Program Co-ordinator and Industry Institute Interaction Co-ordinator.

✓ ***The duration of the self – learning courses will be 8 weeks / 30 hours for 2 credit courses and 12 weeks / 45 hours for 3 credit courses.***

Continuous Evaluation for 30 Marks:

- ❖ Assignment - I & II - 10 Marks (based on theory syllabus as per regulations)
- ❖ Sessional Examination – I - 12 Marks (based on theory syllabus as per regulation)
- ❖ Sessional Examination – II - 12 Marks (based on Laboratory Task)
- ❖ Home Assignment - 05 Marks (group Assignment Laboratory Task)
- ❖ Attendance - 03 Marks

The final marks for the continuous evaluation are awarded as per the VR 17 regulation.


Semester End Evaluation for 70 Marks:

Semester end evaluation is for 70 marks which will be awarded following the same procedure applicable to other theory courses in the semester end examinations as per the VR 17 regulation.
